ENSURING THAT PARTNER FAMILY MORTGAGE PAYMENTS ARE CAPPED AT 29% OF GROSS ANNUAL INCOME, BRHFH SAFEGUARDS AGAINST COST BURDENS. AS AN AWARD-WINNING AFFORDABLE HOUSING BUILDER, BRHFH FOCUSES ON CONSTRUCTING QUALITY, DURABLE, AND WELL-DESIGNED HOMES, MAKING THEM NOT ONLY AFFORDABLE TO BUY BUT ALSO TO MAINTAIN IN THE LONG TERM.
